

## Next Year Astiva Health's Part B Rebate is \$174.70!

The money will be loaded into a Wex Mastercard, and the full amount is available immediately.

You don't need to take any action if you are currently enrolled in Premier Plan (HMO) 010 as you are automatically eligible for this new benefit.
